## AMD STREAMER CHALLENGE Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS PROMOTION IS INTENDED FOR PLAY IN ELIGIBLE COUNTRIES ONLY. - 1. **Sponsor**: AMD Streamer Challenge ("**Promotion**") is sponsored by Advanced Micro Devices, Inc., 2485 Augustine Dr., Santa Clara, CA 95054 ("**AMD**" or "**Sponsor**").
- 2. <u>Overview</u>: The Promotion consists of two phases. Phase 1 of the Promotion involves the selection of Participants to participate in Phase 2. Phase 2 of the Promotion involves Participants competing, either on teams or individually, against each other and/or certain professional gamers (selected by Sponsor) by remotely playing video games live. - 3. <u>Eligibility</u>: The Promotion is open only to legal residents of Japan, Korea, Indonesia, Malaysia Philippines, Singapore, and Thailand, who are at least sixteen (16) years of age as of the start of the Entry Period (defined below), and who submit a valid Entry (as defined below) ("Participant"). Phase 1: From 11 September 2020 at 0900 hrs GMT+8 until 20 November 2020 at 2359 hrs GMT+8 (the "Entry Period"), eligible individuals must visit https://amdgaming.gg/ ("Website"), complete all required fields, and submit a complete entry form for an opportunity to be selected to participate in Phase 2 (each an "Entry"). Eligible individuals will be asked to select their country of residence as well as the Episode(s) in which they would like to participate. Eligible individuals can only participate in certain Episodes based on their country of residence as set forth in Section 7 below. Eligible individuals may only register once per Episode (multiple entries will be voided). Sponsor's server is the official timekeeping device for the Promotion. Entries that are submitted before or after the Entry Period will be void. Failure to include the required information on the Website form will void the Entry. Participant gives Sponsor, its designees, successors, assigns, and licensees a royalty-free, irrevocable, non-exclusive worldwide license to use, reproduce, modify, publish, create derivative works from, and display Participant's name, city and country of residence, alias, avatar, image, recording of Participant's game play (if applicable) and other information provided by Participant, including in Participant's Entry, in any manner, in whole or in

6. Selection for Phase 2: Eligible Participants who have timely completed the registration process in Phase 1 will be assigned to an Episode and a team, if applicable, during Phase 2 on a first come first serve basis, subject to verification. The potential Phase 2 Participants will be contacted a minimum of five (5) days before their applicable Episode airs (as set forth below). Potential Phase 2 Participants will be required to sign and return an Affidavit of Eligibility, Liability, and Publicity Release ("Affidavit"), which must be submitted as described in the notification e-mail within twenty-four (24) hours of the time of notice or attempted notice is sent. During each Episode, Phase 2 Participants will play the applicable Game specified above in the corresponding Format specified above. While playing in an Episode, Participants must use the same account they used to register for the Promotion. In the event of a tie, if applicable, a tie breaker will be based upon the tie-breaking criteria set forth in the Format details above.
